Organized by the Global Initiative Against Transnational Organized Crime (GI-TOC) and co-sponsored by France, the EU, Germany, Norway, Kenya, Peru and Colombia.

In April 2025, the Republic of France and the GI-TOC, supported by the European Union through the ECO-SOLVE project, hosted a security and development dialogue to enhance multilateral and multistakeholder responses to crimes that affect the environment. This side event will present the outcomes of this unique international conference, in advance of upcoming multilateral meetings that will address crimes that affect the environment.

With a focus on the recommendations produced by the conference, the event will help to prepare delegates for several upcoming multilateral events, including the meeting of the Expert Group on crimes that affect the environment under the Conference of the Parties to the UN Convention against Transnational Organized Crime, the Conference of the States Parties to the UN Convention against Corruption, the 15th UN Crime Congress, the UN Oceans Conference, and the UN's climate and biodiversity frameworks. Speakers will include prominent participants from the April multistakeholder conference.

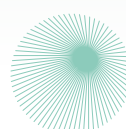
